Target Market Summary

The Fund primarily invests in a concentrated, high conviction portfolio of Australian shares. This product is likely to be appropriate for a consumer seeking capital growth and to be used as a small to core component of their portfolio where the consumer has a medium investment timeframe and a high risk/return profile.

Investment Products and Diversification
