Target Market Summary

The Fund primarily invests in a portfolio of undervalued, high dividend yielding Australian companies. This product is likely to be appropriate for a consumer seeking some capital growth with stable, tax effective income and to be used as a small to core component of their portfolio where the consumer has a medium investment timeframe and a medium risk/return profile.
