#### **Target Market Summary**

The Fund primarily invests in a diversified portfolio of high yielding investments primarily through the US syndicated loan market. This product is likely to be appropriate for a consumer seeking some capital preservation and some stable income to be used as a small allocation within a portfolio where the consumer has a medium investment timeframe and a medium risk/return profile.
